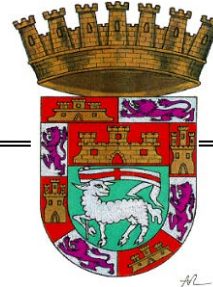

## NOTICE TO OUR CUSTOMERS

### CONSUMER PRICE INDEX ADJUSTMENT EFFECTIVE OCTOBER 1, 2018

In compliance with County Ordinance 2013-13, the water, wastewater and reuse rates along with Unit Connection Fees will increase by 2.9 percent. This increase is based on the current Consumer Price Index of all Urban Consumers (CPI-U), as recorded by the Bureau of Labor Statistics of the U.S. Department of Labor for July 2018. This increase will be seen on your first full billing cycle after the effective date.

Block 3 (8,001 – 16,000 Gallons)	<b>\$6.62 per 1,000</b>	<b>\$6.81 per 1,000</b>
Block 4 (16,001 Gallons & Over)	<b>\$9.60 per 1,000</b>	<b>\$9.88 per 1,000</b>

##### WASTEWATER

*The volume charge for multi-family users shall not exceed 8,000 gallons per dwelling unit.*

##### UNIT CONNECTION FEES

Water - per single family dwelling or ERC	<b>\$1,952.76</b>	<b>\$2,009.39</b>
Wastewater - per single family dwelling or ERC	<b>\$2,472.31</b>	<b>\$2,544.01</b>

#### Commercial, Industrial Combination & Reuse:

All base rates and usage rates will increase by 2.9 percent based on number of ERC's per meter size.
